Orphan Train Riders to be Feted

June 2010

AHA - Adoptees Have Answers along with the Minnesota History Center is hosting "Celebrating the Lives of Minnesota's Orphan Train Riders" on Saturday, June 19 from 2:00 p.m. to 5:00 p.m. at the Minnesota History Center. The event spotlights what many believe was the beginning of the foster care concept in America, when from 1853 to the early 1900s, as many as 200,000 destitute children were sent in trains from New York to live on farms around the country. Minnesota has 11 riders, the most surviving of any state, with seven expected to attend the event where they will be feted in a program of music, film and tributes. Emceed by Ron Peluso, artistic director of the History Theater in St. Paul, the program will include performances by original cast members of *The Orphan Train* musical drama. Riders will speak on a panel, two youth will present Orphan Train projects that won national and state History Day prizes, and a video of Orphan train rider, Sister Justina Bieganeck will be shown.

Russia Tightens Restrictions Around Adoption

May 2010

A tentative bilateral agreement between Russia and the United States has been reached to ensure safeguards in adoptions of Russian children. Talks between the countries will continue to discuss early areas of accord including requirements that adoptive families and agencies must report on the health and well-being of children. Russia will allow adoptions only through agencies that are accredited with the Hague Adoption Convention.

Indiana Highlights Father Engagement

June 2010

The loss and non-involvement of nonresident fathers contributes to children entering the child welfare system. The Indiana Department of Child Services is collaborating with the [Fathers and Families Center](#) to create a pilot program to improve outcomes for children in Marian County, Indiana. Participating fathers attend support groups and learn parenting skills and have access to legal counsel. Project leaders credit the program with instilling in them as well as with their clients the importance of inclusion of fathers in all processes of child welfare.

***Adopted* Now Available on Netflix**

Adopted takes a look at the complexity and unpredictability of transracial adoption. First-time director Barb Lee reveals the lives of two well-meaning families and shows us the subtle challenges they face. One family is just beginning the process of adopting a baby from China and is filled with hope and possibility. The other family's

adopted Korean daughter is 32-years-old and prompted by her mother's terminal illness to create a bond with her that she had never shared before. States Enact Adoptee Access Legislation

May 2010

Illinois governor signed a bill on May 21 that allows adult adoptees, 21 or older, to get their original birth certificates. A birth parent of an adoptee born after 1945 can veto disclosure of the birth parent's identity so long as the birth parent is alive.

New York and New Jersey, after many years of having bills held up by those in opposition, have access bills that are moving forward. An access bill in Rhode Island unanimously passed the House and advances to the Senate for consideration.

Foster Children Sue New York City

May 2010

A federal lawsuit was filed last month to bar New York City from allowing foster care children to be kept in psychiatric hospitals after doctors have recommended their release. The Legal Aid Society, a nonprofit group that represents foster care children in New York, is seeking a preliminary injunction ordering the release of three children who are currently hospitalized despite doctors' recommendations they be released. They have also filed a court order prohibiting the city from continuing to place foster-care children in hospitals unless medically necessary. The United States District Court in Brooklyn, claims that the children who no longer require hospitalization have limited access to schooling, family visit and walks outside.

Educational Neglect Investigations Wane

In harsh economic times, the numbers of children entering foster care typically increases. As states report fewer numbers of children entering into care, one reason may be that less funding is available

for child protection services except for the most egregious of cases. Faced with hard decisions, some states and counties have assigned education neglect to be the least harmful of child protection concerns. Poor school attendance is an indicator of many future problems including criminality, substance abuse, job instability and incarceration. Although the largest category of child endangerment reported by schools, educational neglect is the hardest to prove according to Dr. Andrea Sedlak, researcher with the Westat's Human Services Research Area. Neglect rates (13.1 per 1,000) outpace the rates for abuse (11.1 per 1,000) as a cause for children entering the child welfare system.

Juneteenth Offers Celebration...and Recruitment

Around the nation Juneteenth Festivals of Freedom celebrate the freedom of African Americans from slavery in a commemoration that began in Galveston, Texas on June 19, 1865. On Saturday, June 19, the Twin Cities will host their annual Juneteenth Festival in North Mississippi Regional Park. The event includes a parade, food, music and family fun that is centered around African American culture.

MARN will host a booth to inform and recruit families for Minnesota waiting children. According to the most recent national government report, 30 percent of the children in foster care waiting to be adopted are African American.

Supreme Court Rule Impacts Child Protection

May 2010

A recent ruling by the Minnesota Supreme Court requires counties to pay legal fees for indigent parents in child protection cases. The decision arose after Rice County challenged a lower court ruling to have them pay for a private lawyer for a woman whose newborn had been removed. Some counties with budget shortfalls have cut fees to pay lawyers creating a conflict about which branch of government should incur the costs since such parents require legal representation. The Court's decision puts the cost of representation back on counties.
