CBS to Broadcast 15th Annual "A Home for the Holidays," December 18, 2013

Bill Would Help Fostered Children Attend College

Higher education evades many formerly fostered and homeless children, a situation addressed by a new bill proposed to the United States Senate. The bill, S 1754, would entail significant changes for colleges and federally-funded education programs, requiring state schools to offer in-state tuition fees to any homeless or fostered youth and improving assistance and recruitment by colleges of this population. It would also ease the calculating of financial aid by not factoring in two major sources of aid required of the general population.

New Research Explores Impact of Social Media/Technology On Adoption

Adoption policies and practices have been irreversibly altered by modern technology according to a multiyear research project conducted by the Donaldson Adoption Institute. The Internet, blogs, chat rooms, webinars and photo-listings challenge current laws and policies as well as ethics. The study concludes that professionals and practitioners should revise practices to help clients prepare for full disclosure and that children will know their birth family at some point; that adoption-related websites should be reviewed to prevent exploitation of children; and that laws should be enacted that provide access of adopted persons to their original birth information.

Essays Illuminates the Adoption Experience

The Declassified Adoptee: Essays of an Adoption Activist is receiving attention as a "must read" book that provides understanding from an adopted person's perspective. Author Amanda Transue-Woolston is known as a blogger in the adoption activist community where she expertly explores the personal and political backdrop of being adopted. The essays moved from social media into print after numerous adopted persons shared Transue-Woolston's thoughts with parents, adoption agencies and legislators in an attempt to better explain the adoption experience from the inside out.



Mandela Was Adopted

Nelson Mandela, the South African anti-Apartheid leader, who was born into the Thembu sub-tribe nobility of the Xhosa people in Mvezo, South Africa, was adopted. After the death of his father when he was 9, he was taken to the larger village of Mqhekezweni, the Thembu provincial capital, where he was informally adopted by the Thembu chief Jongintaba.

Ohio Opens Adoption Records

This month Ohio lawmakers passed legislation to help adults adopted in the state get their original birth certificates. If the governor signs the bill, an approximate 400,000 adopted persons who were adopted between January 1964 and September 1996, or their adult direct descendants, will be able to request their adoption files from the Ohio Department of Health's Bureau of Vital Statistics. Those adopted before and after the dates already have access.

Re-Homing Prompts Media and Congressional Response

Reporters continue to explore the unlawful practice of "private re-homing" following a five-part investigative *Reuters* report on families using the Internet to find new homes and illegal placements for adopted children. A November 21, 2103 *New York Times* Op Ed piece attacked the phenomena for not screening those taking in the children who are looking to adopt without a formal process and the associated costs. A congressional bill, HR3423, was introduced on November 21, 2103 that would fund pre- and post-adoption support services, expanding those services to including adoptions from other countries, provide post-adoption mental health services for all adopted children and better track disruption and dissolution rates in states.

Research Counters "Myth" of Promise of Confidentiality to Relinquishing Mothers

Legal scholar Elizabeth J. Samuels concludes that surrendering mothers in adoption cases were not offered nor guaranteed lifelong anonymity. The report is based on Samuels's analysis of relinquishment documents of placing mothers in adoptions of newborns that occurred from 1936 to 1985. The argument that first mothers were promised anonymity has often been used to oppose the right of adopted persons to their original birth certificates in the access movement.

Russia Grants Italy Sole Adoption Rights

Because Italy does not recognize gay marriage, Russia has announced that it will be the only country whose citizens are able to adopt Russian children. While a Russian official clarified that the policy does not prohibit adoption to other countries, the United States is the only country still banned from adopting Russian children.

Multiple Placements Common for Children in Foster Care

While the national number of children in foster care is declining (In 2011, 401,000 children were in foster care, a 29 percent decline from the 1999 peak of 567,000), a high percent of foster youth experience three or more placements in their first year in foster care. A new report in *The Chronicle of Social Change* finds that in 38 percent of states, 10 to 20 percent of foster youth had multiple placements after a removal to foster care. Minnesota fared better than most other states, reporting 85.6 percent of children in 2011 experiencing 2 or fewer placements, with 13.4 percent having 3 or more placements in the first year of care.
