## World / National News

### Adoption Groups Protest Horror Film

July 24, 2009

A number of groups within the adoption community have unified to protest *Orphan*, a terror genre film that is fueling negative attitudes

toward children in foster care who are adopted. Some adoption advocates are urging a boycott of the movie which opened July 24. A coalition of prominent national adoption and foster care groups have asked for a meeting with Warner Brothers Studios' CEO Barry Meyer to discuss their concerns.

A concern expressed about the movie is that it promotes the stereotype of older adoptive children as "damaged." Protesting groups have succeeded in persuading the studio to remove one line from the movie ads: "It must be hard to love an adopted child as much as your own."

### **Romanian International Adoption Update**

July 24, 2009

After a 2001 moratorium on adoptions of children from their country, Romania is facing mounting pressure to reopen their doors to international adoptions. A scandal in late July concerning the illegal adoption of two Romanian minors in Italy has refueled the conflict as has a letter delivered by United States Secretary of State Hillary Clinton during an official visit. The letter, signed by various Senators, was initiated by the Congressional Coalition on Adoption, a private body, that under Senator Mary Landrieu supports resuming adoptions from Romania. Foreign Minister Cristian Diaconescu has stated that Romania intends to maintain its position of suspending international adoptions except to relatives under current law.

### **Disrupted Adoptions Increase in UK**

July 10, 2009

According to survey results reported in *The Times*, the number of children in Great Britain returning to foster care after being adopted has doubled in recent years. Of the 3,000 adoptions occurring annually, approximately 1 in 15 fail. The children tend to be older and come from backgrounds of neglect and abuse. Numbers of adoptions are declining despite former Prime Minister Tony Blair's 2002 adoption law which was intended to increase adoption of children from foster care. The law encouraged adoption by single parents and gay couples, but the article suggests that attitudes from church agencies and social workers disapproving of this population as adoptive parents may be a factor. Another factor may be that the criteria for adopting precludes couples considered too old, too unfit, or having undesirable views on matters like race equality.

### **Language Barrier Thwarts South Korean Reunions**

July 17, 2009

South Korea may be falling short of provisions of services to adoptees searching for their birth families because the official website is written in Korean. The Ministry of Health, Welfare and Family established the website ([www.kcare.or.kr](http://www.kcare.or.kr)) to be in compliance with the Hague Convention on Intercountry Adoption and to provide post adoption help to adoptees searching for their birth family. Reunion rates are low with only 2.7 reunions occurring among the 78,000 adoptees who went to South Korea to search for their birth families from 1995-2005.

### **Welsh Council Bans Smokers From Adopting Foster Children**

July 25, 2009

A council has become the first in Wales to impose a blanket ban that prohibits smokers from adopting or fostering children. Anti-smoking campaigners welcomed the move by Merythyr Tydfil Council, but critics have already pointed out the lack of foster parents in Wales. Some fear the changes might discourage potential care givers from coming forward and could impact the future of children already in the care of smokers.

### **Homeland Trips Increase for Younger Children**

July 29, 2009

International travel with a purpose has become a mainstay in the adoption world for parents who, with their adopted children are making return trips to the child's country of origin. For children, as young as 7-year-old Chloe Cohen, who with her parents recently made a trip to Guatemala, the result is an observation that Guatemalans "look different from people here - except me."

Susan Soonkeum Cox, Vice President of Policy and External Affairs for Holt International, encourages such trips for the sake of the child. "They are tourists, but there's a uniqueness about them going back that's deeply profound."

### **Legislation Pends to Waive Immigration Requirements for Adopted Children**

July 8, 2009

Senate bill #1376, sponsored by Senator Amy Klobuchar (MN), Senator Durbin (IL), Senator Feingold (WI), Senator Inhofe (OK), and Senator Landrieu (LA), would restore immunization and sibling age exemptions for children adopted by United States citizens under the

Hague Convention on Intercountry Adoption to allow their admission to the United States.

This act allows waivers of the immigration immunization requirements for children adopted from Hague partner countries. It also allows children up to the age of 18 to be adopted and admitted into the United States if they are siblings of previously adopted children. This bill addresses oversights in the drafting of the Hague Regulations and brings those regulations into parity with existing international adoption law and policy on immunization waivers and sibling adoptions. Some adoptive families are being delayed in bringing their children home and having to stay in the country additional time. In some instances, children are having multiple shots for immunization just prior to boarding the plane.

### **Missouri Favors Grandparents in Foster Placements**

July 8, 2009

Missouri Governor Jay Nixon signed legislation (HB154) into law July 8, 2009 that requires the state to make diligent efforts to place a child with a grandparent for emergency and foster placements. The law also requires each school district to establish an educational liaison for children in foster care to facilitate school placement and record requests.

### **Virginia Permits 'Cooperative Adoption'**

July 1, 2009

A new Virginia state law (Chapter 260) took effect on July 1 that allows a foster child's birthparents(s) and pre-adoptive parent(s) to enter into a written post-adoption contact and communication agreement. The court may approve an agreement if it find that it is in the child's best interests, both sets of parents have consented, the agency and guardian ad litem recommend approval and, if the child is 14 years of older, he/she has consented. The law provides birthparents the right to seek to enforce these 'cooperative adoption' agreements.

Recently the young actor not only located his birth mother, but both Ryan and his birth mother soon will be performing together as 'mother and son' in a production of *True West* in Lincoln, Nebraska. Using the search engine Google, Kathman learned that his birth mother had earned the master of fine arts degree that he pursues at the same university he attends. His birth mother, Moira Mangiameli, 50, has earned acting accolades at various area theaters since before Ryan was born. The casting was purposefully engineered by the director who stepped down from the role of Ryan's mother in the play and cast Ryan's birth mother to play the role soon after the reunion took place.

## Inside News

### State Extends Foster Care Benefits

Minnesota youth in foster care who are nearing their 18th birthday will have the option of staying in foster care, if they think they are not yet ready to live on their own. A new law, 260C.4561, signed by Governor Tim Pawlenty takes effect on August 1, 2009 that requires social services agencies to develop a plan with the child for their vocational, educational and social needs. Agencies must also ensure that any foster care, housing or counseling benefits are consistent with that plan.

### MARN Launches State-Contracted MN ADOPT

July 1, 2009

MN ADOPT, an initiative to serve the needs of families before and after an adoption, began on July 1, 2009. MN ADOPT is a state-contracted program between MARN and the Minnesota Department of Human Services to manage the State Adoption Exchange and the Adoption Information Referral and Training System.

New and prospective parents can turn to MN ADOPT for advice and support about parenting in general or about adoption in particular. The program seamlessly combines pre- and post- adoption information available at [www.mnadopt.org](http://www.mnadopt.org), through email and phone inquiries. For those interested in adopting children under state guardianship, the State Adoption Exchange includes an online database listing children in Minnesota who are available for adoption as well as a slate of pre-adopt orientations and trainings offered by private and county agencies throughout the state. Other features of MN ADOPT include the provision of statewide training (online and in person), a system of referral to professionals and services, and a listing of multiple resources helpful to parents and professionals. information about support services offered by private agencies, counties, tribes and individuals.

Warren Wolfe at the Star Tribune reports, "Child poverty in Minnesota rose 33 percent between 2000 and 2007, six times the national average, and several other measures of child well-being declined."

**Nonprofits Feel Economic Heat**

August 2009

According to the results of a recent Minnesota Council of Nonprofits (MCN) survey published in Nonprofit News, Minnesota nonprofits continue to face decreased budgets and increased demands for services. MCN Executive Director, Jon Pratt says, "Minnesota's nonprofits continue to be seriously affected by the recession, with 57 percent of organizations reporting reduced revenues. 2009 presents an immense financial challenge for the nonprofit sector, struggling to budget appropriately in the face of government reductions and economic instability."

**Likely Candidates for Transracial Adoption Defined**

June 2009

The July 2009 issue of *Family Relations* published a study done by Abbie Goldberg and Julianna Smith who investigated factors predicting openness to adopting an African American child among couples seeking to adopt their first child. Demographics favorable to predicting who might adopt African American children included the parents being young, being white (rather than a non-black minority), being lesbian rather than heterosexual, pursuing public versus private domestic adoption, and perceiving their neighborhood as "diverse."

## Early Deprivation, Abuse Alter Brain Development

A pilot study investigating the impact of early deprivation on brain development through the use of MRIs has discovered the area of the brain called the amygdala greatly altered. The amygdala guides social interactions and governs emotional processing. Researchers Mitul Mehta, Nicole Golembo, Chiara Nosarti, Emma Colvert, Ashley Mota, Steven William, Michael Rutter and Edmund Sonuga-Barke found that children adopted from Romania who had experienced institutionalization had significant differences in their brain structures compared to non-adopted adolescents with more profound alteration paralleling longer stays in institutions. Results are published in the August issue of the *Journal of Child Psychology and Psychiatry* (Volume 50, Issue 8).


