Ireland Pushes for Release of Birth Record October 2010

Adopted people in England, Wales and Northern Ireland have had the right to their birth certificates and adoption files since the 1970s. Ireland does not allow adopted adults to get their original birth certificates or information contained in their adoption files. A coalition of adoption and children's rights organizations was established earlier this year to urge Minister for Children, Barry Andrews, to amend Ireland's 2009 Adoption Bill in order to include adoptee access to their original birth certificates. While the Adoption Bill addressed concerns with international adoption, it did not reference a 1952 Adoption Act that prevents release of information unless the birth mother's permission was received.

Pennsylvania Reduces Foster Care Numbers September 2010

Following a national trend, Pennsylvania is touting a 12 percent drop in foster care numbers this year, calling it "significant progress." The state reports that the decrease does not mean that children's safety has been endangered. Repeat cases of child abuse did not measurably increase and re-entry into foster care was reduced. Pennsylvania also reported that African American children are six times more likely than white children to enter foster care and more likely to not find a family.

Adoptive Parents Must Return Son to Birth Father

September 2010

After a three year court battle, an Indiana couple will be required to return their adopted child to the child's biological father in Ohio. The case is based upon the birth father complying with the state's Putative Father Registry in Ohio, stating his intent to establish parental rights. Paternity was never established since the birth mother was not married to the child's birth father and she did not provide information on the birth father to the adoption agency. The Ohio court ruled that the adoption petition had been filed prematurely since paternity had not yet been determined.

Maryland Reports Increase in Adoption

August 2010

According to the Maryland Department of Human Resources approximately 8,760 children have been placed with guardians, adoptive families or reunited with their parents which has helped the state achieve a 20 percent increase in the number of adoptions over the past three years. Governor Martin O'Malley says his "Place Matters" initiative aims to find more stable and secure homes for children in foster care. Much of the progress is taking place in Baltimore where the number of group home placements has dropped 71 percent. "Three years ago, the state had difficulty even establishing the number of children in foster care," says Governor O'Malley.

Florida's Governor Overturns Ban on Adoption by Same Sex Couples

September 2010

Governor Charlie Crist has stopped enforcing a 33-year-old state law banning adoption by same sex couples in Florida. This follows an appeals court decision making the ban unconstitutional and now awaits a final decision by the Florida Supreme Court. The state allows same sex couples to become foster parents or legal guardians, but prevents them from adopting.

\$39 Million Awarded in Adoption Incentives

September 2010

The U.S. Department of Health and Human Services is awarding \$39 million to 38 States and Puerto Rico for increasing the number of children adopted from foster care in Fiscal Year 2009. Originally created as part of the Adoption and Safe Families Act of 1997, the Adoption Incentives program awards \$4,000 for every child adopted beyond the State's best year total. States may receive additional awards for increasing adoptions of older children and children with special needs. This fiscal year, Minnesota will receive \$446,408.

IRS Expands Adoption Credit

October 2010

An expanded adoption credit for tax year 2010 raises the maximum adoption credit to \$13,170 per child, up from \$12,150 in 2009. It also makes the credit refundable, meaning that eligible taxpayers can qualify even if they owe no tax for that year. The credit is based on the reasonable and necessary expenses related to a legal adoption including adoption fees, court costs, attorney's fees and travel expenses. Income limits and other special rules apply. Documentation requirements preclude e-filing and necessitate filing a paper return.

New Book Examines 'At Risk' Children

October 2010

In his newly-released ninth book, *The Mystery of Risk*, author Dr. Ira Chasnoff explores a label commonly attached to vulnerable children, that being "at risk." Using clinical cases from his practice at the Children's Research Triangle in Chicago, Chasnoff provides ways to parent and to teach children who have experienced trauma, neglect an in-utero exposure to alcohol. His book suggest that preventive, integrated systems of care are needed to avoid multiple stays in foster care and adoption disruptions. Chasnoff is a professor of clinical pediatrics and the University of Illinois College of Medicine and is a researcher in the filed of prenatal exposure to alcohol and illicit drugs.

Research

Research Shows Limits of Child Protective Services

October 2010

Research from Dr. Kristine A. Campbell of the University of Utah in Salt Lake City finds child protections investigations do not improve future outcomes for families. Such investigations were neither a "wake up call" nor did they abate risk factors for children in families under investigation. Exceptions that prevented first-time or repeat abuse were interventions such as parent-child interaction therapy, increased support and cognitive behavioral therapy.

September 2010

The Twin Cities hosted the first screening of the film *ADOPTED: For the Life of Me* to a standing room only crowd on September 23, 2010. Jean Strauss told the audience that Minnesota was the first to seal birth records for adopted persons, so the venue was significant as the premiere of her film that addressed the impact of secrecy on aging adoptees. The four-years-in-the-making documentary is scheduled to be shown on PBS stations in November.
