## Washington State releases birth certificates for adopted adults

Beginning July 1, 2014 a new law allows open access to original, pre-adoption birth certificates for all Washington-born adult adoptees. The state expects a rush from adopted persons. Birth parents may file a contact preference form regarding their preference for contact and are required to file medical information. If a birth parent doesn't file a contact preference form, the adoptee will be able to get a copy of their original birth certificate.

## Child returned to birthfather

Nine-year-old Sonya was returned to her birthfather, John McCaul. Tennessee had automatically terminated his rights when he went to prison. Sonya's adoptive parents, Kim and Dave Hodgin, contested the decision but on May 16, A judge blocked an attempt by Middle Tennessee foster parents to get back physical custody of the child they raised for eight years. The family's lawyer said, "Despite repeated efforts by the foster family to terminate this child's father's rights, his parental rights have never been successfully terminated, and his daughter has now been returned to his care."

## Children found in mass grave at maternity home in Ireland

On June 3, 2014, nearly 800 children were found in a mass grave near a former home for unwed mothers and their children in Ireland. The grave was found in a septic tank on the grounds. The children entombed appeared to have died between 1925 and 1961 from infectious diseases or malnutrition. Unsanitary conditions are thought to be a major factor in the deaths. Two boys discovered the grave while playing near St. Mary's Mother and Baby Home. Leaders in the Catholic Church are meeting to discuss plans for a memorial for the 796 children and calling for an inquiry into the mass grave.
